



THE ORGANISATION

THE POSITION

- Previous experience with HIV work is preferred.
- At least two (2) years' experience with clinical case management of HIV/AIDS.
- Ability to read, write, and speak local language will be an advantage.
- Must be registered with the Pharmacy Council of Namibia.

- Diploma/Degree in General Nursing and Midwifery
- Any additional post-graduate qualification will be a distinct advantage.
- Experience in the treatment of HIV will be an added advantage.
- Ability to maintain professional confidentiality at all times.
- Ability to create a conducive atmosphere for patients, relatives and colleagues. Previous experience with HIV work is preferred.
- Previous experience in doing HIV-related operational research is an advantage, relatives and colleagues.
- Must be registered with the Namibia Interim Nursing Council.
