REGIONAL CLINICAL MENTOR (Omusati Region) Fixed-Term Contract

The Position

The candidate will be involved in the provision of on-site clinical training to Health Care Workers (HCWs) on the Management of HIV cases according to the Namibian national guidelines.

Key areas of focus

1. ART site-specific HIV -related mentoring and support: 85%

- Provide on-site clinical training to HCWs on the management of HIV-infected patients according to the Namibian national guidelines, including Adult and Pediatric ART, PMTCT including early infant diagnosis, and the treatment of tuberculosis, STIs and other opportunistic conditions.
- Provide training through clinical consultation, assist local HCWs to problem-solve complex cases and helping them with patient care as needed.
- Assist, in collaboration with heath facility stakeholders, in the development of standard operating procedures for the provision of HIV
 clinical care at the ART clinics. This may include, for example, trouble-shooting problems with patient flow within the clinics, tracking
 defaulters, or clarifying referral pathways by developing appropriate algorithms.
- Provide technical guidance to HCWs and closely support operational research practices at the health facilities, district and regional levels.
- Attend and facilitate Project ECHO sessions, Quality Improvement webinars and Mentor meetings.
- Facilitate and coordinate Project ECHO sessions to augment the ongoing clinical training and mentoring efforts.
- Submit a monthly report on mentoring and technical assistance activities including findings, lessons learned and success stories with recommendations for strengthening services in the health facilities in compliance with the national treatment guidelines to the CMO at the region, Chief Clinical Mentor and Chief CMO at MoHSS DSP.
- Participate as a member of the MoHSS regional support visit team for the assigned region and/or other regions as required.
- Provide technical support to the district nurse mentors as required.
- Participate in establishment and institutionalisation of a functional continuous quality improvement system for the assigned health care facilities in the assigned region.

2. Non-mentoring support for quality of HIV-related care and treatment: 15%

- Provide didactic HIV-related training sessions to health professionals, both in the state and private sector, as needed, according to
 established curricula and using various methodologies (including distance learning).
- Assist as requested with updating and revision of HIV-related training materials and national guidelines.
- Participate at national level in the establishment and institutionalisation of functional continuous quality improvement systems.
- Be part of Quality Management trainings and other activities organised by MoHSS Quality Assurance division.
- · Perform any ad hoc duties within the ambit of the position and as required by MoHSS.

 experienced patients and management of drug resistance HIV.

- At least 1 year experience of HIV Quality improvement methodology and project management.
- Ability to write reports, analyse and interpret data.

- Demonstrated ability to be a team player.
- Willingness to travel to clinics and hospitals throughout Namibia.
