The Position

As a Community Adolescent Treatment Supports (CATS) Chief Program Officer, the successful candidate will be responsible for coordinating the upscaling of CATS program at regional level. This will be done by building the technical capacity of MoHSS service providers and by providing support via mentorship of the CATS in the region. This role will also include coordination of all CATS activities in the districts, in accordance with the approved project plans and by ensuring adherence to project management principles. Furthermore, the successful candidate will ensure that all beneficiaries receive the appropriate differentiated care, based on the CATS Intervention Model.

Key focus areas:

- Conduct and execute all CATS coordination meetings.
- Ensure timely submission and accuracy of CATS reports up to national level.
- Provide mentorship and supportive supervision to young people working with CATS at Facility level.
- Provide mentorship and support to facility staff working with CATS.
- Provide supportive supervision during home visits to beneficiaries needing enhanced care by CATS.
- Work closely with Senior CATS to coordinate and upscale the model.
- Assist in strengthening the prevention and response to violence, abuse and neglect of children with HIV.
- Ensure all beneficiaries receive the appropriate level of differentiated care, based on the CATS intervention model.
- Provide in-service training to newly appointed CATS, provide supportive supervision for CATS at facility and also provide refresher training.
- Communicate with the National Paediatric ART Coordinator on progress of the program.
- Provide regional oversight of paediatric and adolescent ART programming.
- Improve and maintain the quality of paediatric care, as well as that of the CATS and Teen club programs.
- Facilitate requests and reports for CATS and Teen Clubs at facility level.
- Complete facility and attendance reports to ensure payment allowance to CATS on time.
- Ensure and support implementation of QI activities.
- Any other duties, which might be assigned by the supervisor.

Minimum requirements:

- A Bachelor Degree in Health Sciences, Nursing or Social Work with emphasis in community health.
- Experience working with children and adolescents (non-negotiable)
- Diploma or experience in clinical psychology would be advantageous.
- At least 3 years' experience in community development and/or mobilisation.
- 2 years' experience in programme management.
- Demonstrated experience in adolescent HIV/ART programming, including community, and peer-led interventions.
- Knowledge and familiarity with the MoHSS.
- Ability to write reports, analyse, and interpret data.
- Ability to work independently and as a team player.
- Ability to work effectively in an evolving policy environment.
- Coordinate and support the efforts of other professionals to meet a complicated need of the program effectively.
- Experience in identifying and analysing complex programs, and develop creative solutions.
- Adequate knowledge of monitoring and evaluation.
- Proven interpersonal skills and the ability to work with people from diverse backgrounds.
- Willing to travel to clinics and hospitals throughout the assigned region.
- Ability to maintain professional confidentiality at all times.
